Accreditation status in the United Republic of Tanzania

1. Testing and Medical Laboratories

In the United Republic of Tanzania, about 100 laboratories have been accredited by SADCAS in terms of ISO/IEC 17025:2017 and ISO 15189:2012. 10 Labs have applied for accreditation and they are at different accreditation steps

2. Proficiency Testing Schemes, ISO/IEC 17043:2010

Laboratories participate in different testing schemes to their accreditation scope as one of the critical accreditation requirements. The PT are procured from abroad and

it has never been cheap in terms of cost and logistics.

To address this challenge, the region of EAC has established a PT scheme provided by the Tanzania Bureau of Standards (TBS), Kenya Bureau of Standards (KEBS), Uganda National Bureau of Standards (UNBS) and Rwanda Standards Body (RSB). Tanzania Bureau of Standards (TBS) has been providing PT at the EAC region and outside the region. TBS, a member of the NLAT, is striving to accredit the schemes to ISO/IEC 17043:2010 as follows:
